  - b. An existing notice board supported by 2-4x4 posts will be in conflict with the new proposed walkway. This notice board is to be salvaged for re-installation.

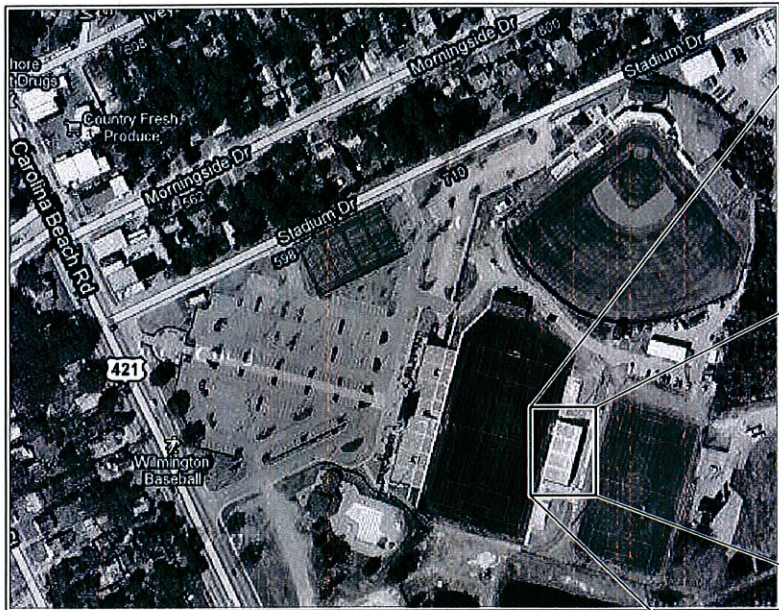
4. Drawing Sheet J-1.12.a; Drawing 3

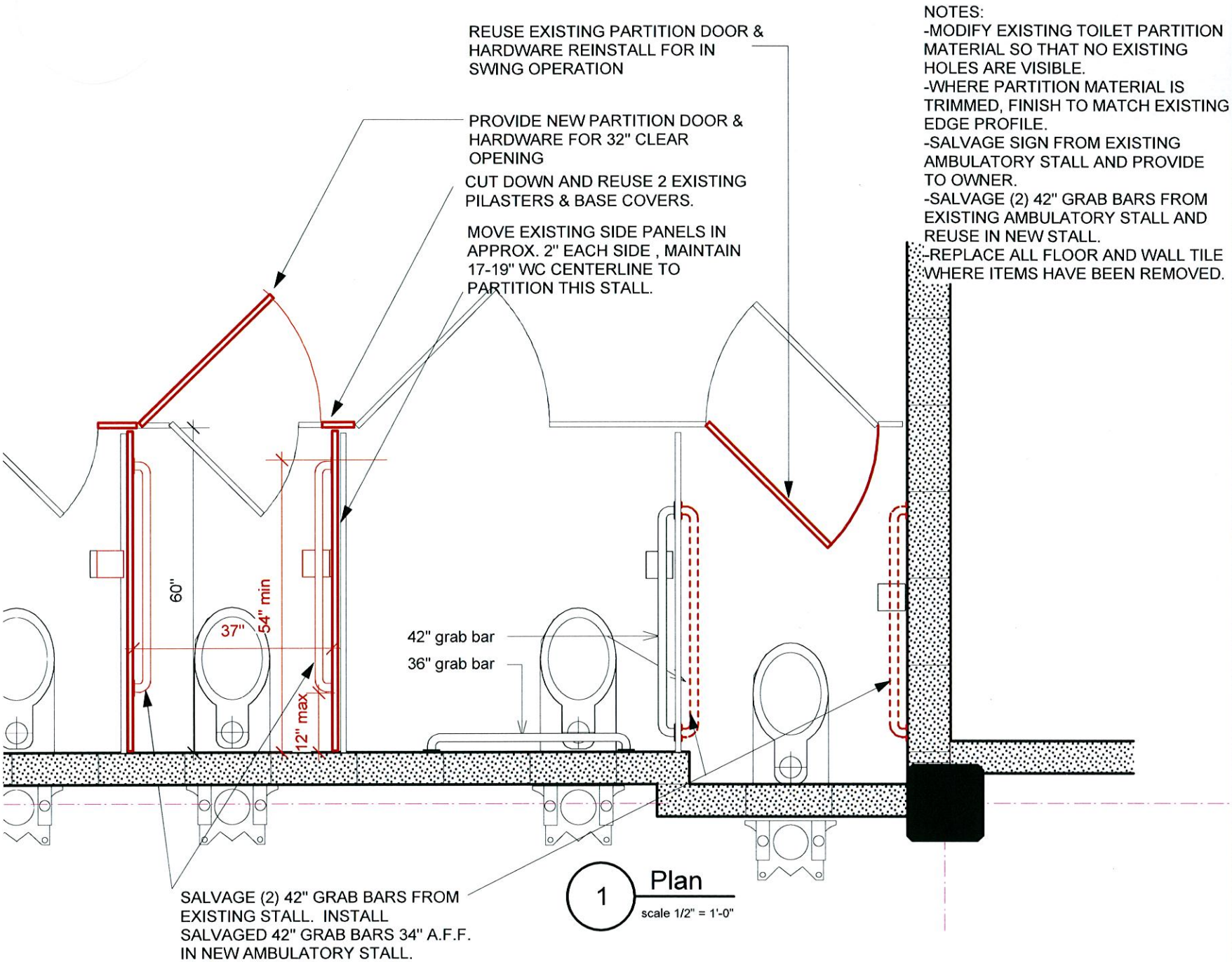

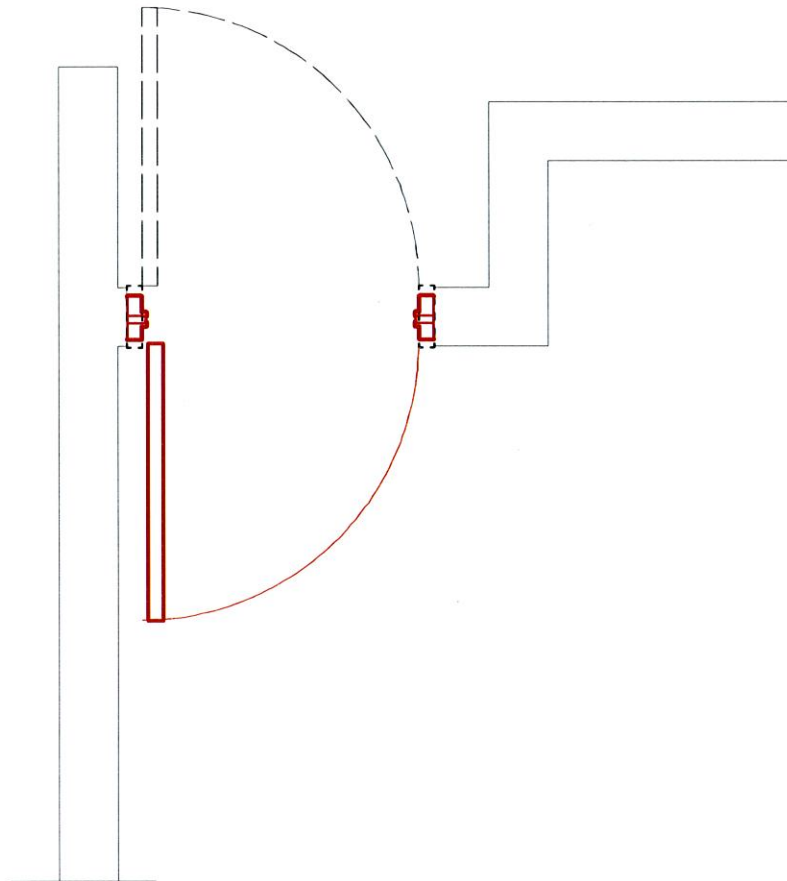

PROVIDE NEW GALVANEAELED HOLLOW METAL DOOR & FRAME. 16 GAUGE X 5"+PROFILE, 4" HEAD, WELDED FRAME WITH EXISTING OPENING ANCHORS, 18 GAUGE DOOR. EXISTING SARGENT 7800 SERIES MORTISE LOCK IS REVERSABLE. RE-INSTALL ALL HARDWARE. INSTALL NEW DOOR FRAME, HANG DOOR, PREP AND PAINT, INSTALL LOCKSET.
