Riverfront Park Performers Rules and Regulations

- 1) No knife, sword, torch, flame, ax, saw, firearm or other hazardous or potentially hazardous material, equipment, animal or object that can cause bodily harm to any person may be used by a performer
- 2) A performer is liable for any damages or injury to the public and Riverfront Park resulting from his/her activities and the performer shall hold the City, its officials and employees, harmless against any and all liability, loss, cost, damages or expenses incurred by the City by reason of the negligence, default or misconduct of any performer
- 3) Performances must be appropriate for families and no performances are permitted after 10 pm, No performances are permitted between 10:00 pm and 10:00 am (unless part of events). Vendors setting up prior to 10:00 am may be asked to vacate the premises for the day.
- 4) No performer shall engage in activity that can cause bodily injury to any person.
- 5) A performer who produces sound will maintain a distance of 50 feet from Visitor's Information Center and any other sound producing performer. Sound amplified electronically or otherwise is not permitted.
- 6) A performer may not perform in any area in which an authorized festival or an official event is underway unless the performer made an arrangement with the organizer or manager of the festival or event and the arrangement is reduced to writing and a copy delivered to Downtown Services and attached to the permit application.
- 7) A performer may not solicit payment for performing either orally or by gesture, except that a performer may display within the permitted location, one professionally generated sign no greater than 8 ½ inches by 11 inches in size that requests donations.
- 8) A performer may not block or obstruct the free movement of pedestrians, vendors or other performers. A police officer, fire official, or city representative may disburse any portion of a crowd for safety purposes.
- 9) A performer shall pay an application fee payable to The City of Wilmington.
