#### **Case Overview**

The applicant proposes to list the parsonage as a local landmark for its architectural, religious, and cultural significance.

Details as shown on the drawings, plans, photographs, submittals, and narrative statement contained in the application, and supplemental materials and statements made at the December 11, 2025 meeting are a part of this request unless otherwise noted.

# **Property Description**

The following property description is adapted from the Wilmington Historic District Boundary Expansion and Additional Documentation report, dated 2003 (originally listed 1974).

Two-story Colonial Revival house with fanlight, sidelights and one-over-one sash. Side-porch. Dormers with arched windows. Pedimented porch roof. 1915 CD: not listed; 1928 CD: Rev. J. T. Pharr; 1943 CD: Rev. Smith Johnston (W), occupant.

## Sanborn Fire Insurance Maps

- 1915 Map. Plat laid out, no development was documented at this time
- **1951 Map**. 2 story brick building with a wood porch to the south of the structure. Building labeled parsonage at 1115. Emanuel Prebyterian church is located to the north of the property. A brick single story apartment is located east of the parsonage.
- **1955 Map**. No change

#### **Current Conditions**

- The subject building is a contributing resource to the Wilmington Historic District but is not located within any local historic district or historic district overlay.
- The property is zoned R-5, Medium-density mixed residential district.

# **Proposed Findings of Fact**

# **Property Information**

- 1. The subject building is a contributing resource to the Wilmington Historic District, originally listed in 1974 and updated in 2003.
- 2. The subject property is located between the blocks of Meares and Marsteller Streets on the east side of South 5<sup>th</sup> Avenue.
- 3. The following Certificates of Appropriateness have been issued for the property: N/A

# Scope of Work

The applicant proposes adding the building to the Study List in anticipation of pursuing local landmark designation for the parsonage.

# **Staff Observations**

- 4. Staff notes the following:
  - a. In 1922, the parsonage and church were dedicated and the major donor of the buildings was Dr. James Sprunt.
  - b. The parsonage and church were a two of the last few projects of architect James Gause.
  - c. The building was last used as a manse by Rev. Patrick Frazier and his family when he served as pastor at Macedonia F.B.H. Church from 1982-1994. He was later appointed Senior Bishop and Chairman of the Board of Bishops of the Fire Baptize Holiness Church of God of the Americas 2005-present.
  - d. The original floor plan was remodeled to have two apartments.
  - e. The original porches on the north and south façade have been removed.





History of Immanuel Presbyterian Manse (parsonage)

The new church, Immanuel Presbyterian Church and parsonage were dedicated 1922. The handsome house of worship almost wholly gifted by Dr. James Sprunt. Dr. Sprunt always gave liberally to the Presbyterian Church. He is remembered as exporter, Cape Fear historian, philanthropist, writer, as well as a blockade runner during the Civil War.

The building was last used as a manse by Rev. Patrick Frazier and his family when he served as pastor at Macedonia F.B.H. Church from 1982-1994. In 1994 he was appointed Bishop of the 2<sup>nd</sup> Episcopal Diocese. He was later appointed Senior Bishop and chairman of the board of Bishops of the Fire Baptize Holiness Church of God of the Americas 2005-present.


The Immanuel Presbyterian Church and manse appears to be James Gause last completed architectural work. According to an article in Architects and Builders, the Wilmington Morning Star of April , 1922, reported that the Cape Fear Country Club , designed by Gause, was to be among the handsomest and best equipped country clubs in the Carolinas. These projects where underway when Gause was stricken ill in May and died in June, 1922. The Wilmington Morning Star described as a leading architect in the city and the state another paper stated he was "widely known" in the south.

#### **General Architectural Features**

The style of the architect is of the Georgian Period. Construction is of brick veneer, hot air heating and slate roofing.


The original floor plan: First floor contained the pastor's study, living room, dining room, den and kitchen. Second floor 4 bedrooms and 2 baths.


The original floor plan was remodeled to two apartments.











































































