ADDENDUM NUMBER 1 10TH ST AND GRACE ST INTERSECTION IMPROVEMENTS PAV-IH-0724 August 22, 2024

To all holders of PAV-IH-0724 Bid Documents: Please be advised of the following questions and responses:

Question 1: Can the bid opening date be adjusted due to the Labor Day holiday?

Response 1:

The bid opening date has been changed to September 12th, 2024, at 3:00 PM. The location of the bid opening has not changed.

Question 2: Can a line item be added to the bid schedule for construction surveying?

Response 2:

Yes, a line item has been added to the bid schedule for construction surveying. Construction surveying will be the responsibility of the contractor and will not be provided by the City of Wilmington.

Question 3: Is a traffic control plan required?

Response 3:

Yes, a traffic control plan furnished by the contractor is required for the project. An example plan is already provided in the bid documents. The intersection may be closed to through traffic but must remain open for residents whose properties are serviced by driveways in the project area.

Question 4: Can the units for the asphalt overlay line items be changed from square yards to tons?

Response 4:

Yes, the units for the asphalt overlay line items have been changed from square yards to tons.

Question 5: What is the schedule for the project and what times are available to work?

Response 5:

The contractor shall complete all work in the contract within 90 calendar days from the date of beginning. Section TS-15.34 on page TS-15-12 in the technical specifications details the project work times. Payment for structure installation shall constitute full compensation for all labor, equipment, tools, supplies and incidentals necessary to complete all items of work, including excavation and backfill necessary to construct the structure, compaction of sub grade, hauling, construction of fills and embankments, spreading, rolling, wetting and disposal of all surplus and unsuitable materials, as indicated on the drawings and specified herein.

TS-15.32 <u>FINAL CLEANUP:</u>

The Contractor shall clear all streets, curbs, gutters, driveways and other contract items of all dirt and debris before final inspection will be made. The City will not inspect the improved areas until they are cleaned. Failure by the City to perform final inspection if the areas are not cleaned shall not relieve the Contractor of any liquidated damages. No extra payment will be allowed for this cleaning. The cost of the cleaning shall be included in each item bid in the proposal.

TS-15.34 **PROJECT WORK TIMES**:

Unless requested in writing and approved by the City in advance, the Contractor shall not be allowed to perform construction activities on City recognized holidays, or before 7:00 a.m. or after 6:00 p.m. on weekdays.
